## **News from the IIABA National Director**

In a message to members this month, IIABA CEO Charles Symington shared His "Top 3" need-to-know association updates for this month below.

#### THE HARD MARKET

Serving both state association and agency members in this very difficult market remains Symington's priority. Several IIABA programs are firing on all cylinders to continue to build resources to help agents and brokers guide their customers in these turbulent times. Some notable updates on market access. the IIABA Executive Committee and AAS Board formed a new standing committee of AAS, the Market Access Committee (MAC), which will be chaired by Jared Blackwood, national board director from North Dakota. MAC has direct oversight of all market access within the for-profit operation. Members include national board members, state executives and state staff members.

**Big "I" Eagle Alliance** will launch January 1, 2024. That date is necessary to ensure that we are in alignment with carriers for profit sharing, etc. Tiffany Overlease, AVP, Eagle Alliance, is managing this program with key support from the MAC. A webinar introducing the program to directors and state executives is scheduled for Dec. 15.

New IT platform for Big "I" Markets -The new IT platform for Big "I" Markets is on schedule, and is expected to launch in April. There are two phases of the platform. Phase I is a new rating and issuance system for Lloyd's of London, which is being tested and will go live in December. Phase II replaces AMS360 and the current Big "I" Markets platform.


**Trusted Choice** - the trusted team has also been busy with various projects set to launch soon to augment our highly successful Hard Market Toolkit. The latest endeavor includes research from a member-facing survey that delves into agent-client

interactions during this challenging market. The results will uncover insights on increased deductibles, staffing and technology trends, and other measures agents are implementing. The team has also developed a series of actual case studies featuring eight agencies from across the country, showcasing their creative solutions for clients that we'll use as examples for others.

Also, the U.S. House Financial Services Subcommittee on Housing and Insurance held that hearing early this month, and the Big "I" submitted written testimony that can be viewed <a href="here">here</a>. Agents' concerns are highlighted and the Big I offered some potential solutions to alleviate market pressure.

With the end of the year upon us, it is nice to reflect on the past year and what has taken place at the Wyoming Department of Insurance.

In 2023 (through December 5, 2023), the Rate and Form filing section reviewed 1,520 Life & Health filings and 2,225 Property & Casualty filings. This work was completed by 5 staff members.

The licensing section in 2023 issued 42,773 licenses and manually processed 5,026 applications. Ninety-five percent of these were handled by 2 licensing specialists which is the smallest office in the country. In the legal section, they revised Chapter 10, 64, 54, 55, 28 and 68 of the rules and regulations. They also drafted and revised numerous contracts associated with financial examinations including 5 actuarial, 5 financial examination and 6 IT examination contracts. They received 80 public records requests with 79 currently complete and opened 65 administrative matters in 2023 with 32 completed/closed to date.

The Department also successfully passed NAIC accreditation in 2023. The NAIC Financial Regulation Standards and Accreditation Program (Accreditation Program) serves as the backbone of the U.S. national system of state-based regulation. The Accreditation Program defines baseline standards deemed essential for effective solvency regulation in each state.

In 2023 there were some legislative changes that ranged from Mental Health Collaborative Care to Wyoming Prescription Drug Transparency. One bill was the Insurance Modernization bill (SF0006-CSEA, no. 0017, Chapter no. 32) that modernized the insurance code to allow insurers or producers to offer non-cash gifts, items or services with the connection of marketing, sale, purchase, or retention of policies. A yearly cap on these gifts, items or services is \$100 or 5% of the written or quoted premium, not to exceed \$1000. For additional information, please see the enacted legislation.

We expect 2024 to be another busy legislative session.




